The financial health of AMMI Canada has continued to remain stable over the last two calendar years, with expenses maintained lower than revenues and modest growth in our financial reserves. This was made possible through the financial success of our Annual Conference, which remains the major source of funds for AMMI Canada's operations. In addition to revenues from membership dues which represent approximately 20-25% of funds needed, an additional new source of revenue was generated through accreditation activities. As per the decision made by Council, 2008 will be the fifth and final year for AMMI Canada's financial support and investment in CFID through salary support of its Director of Development as well as some of their operational activities. AMMI Canada's investments have been sheltered from the economic downturn since they are in low risk, income-generating investments mostly through TD Waterhouse.

This nascent committee was newly formed from the nidus of the AMMI Canada Antimicrobial Resistance Committee, with the addition of "stewardship" as a main focus. Its purpose has been in evolution, and the membership currently includes ID and MM practitioners and representation from antimicrobial utilization pharmacists. Over the past year the main effort was on identifying linkages with agencies with shared goals, and highlighting the need for an organization of this kind to provide an information sharing infrastructure and networking for "stewardship interested" ID and MM practitioners. The number of interested members has increased, but more are welcome as the functions of the committee are delineated.



The main activities this year were as follows:

1) Participation in AMR Consultation on Antimicrobial Stewardship. Dr. Jim Hutchinson, who also is Chair of the Canadian Committee on Antibiotic Resistance (CCAR) helped coordinate cross-Canada, cross discipline AMR Consultation activities with Dr. Howard Njoo, Director General, Centre for Communicable Diseases and Infection Control of the Public Health Agency of Canada. A series of meetings (accomplished at multiple national sites through PHAC teleconferencing) were facilitated in the areas of Surveillance, Research, Antimicrobial Stewardship, Education/Training, and National Coordination and Integration. Our members, provided input in the initial survey, background document preparation, and presentations to frame the discussions on Antimicrobial Stewardship. The reports from these consultations will serve as a basis for planning a Canadian response to antimicrobial resistance at the PHAC level. The CCAR personnel and facilitators should be congratulated for a job well done. As CCAR's federal funding ends in late 2009, this activity was crucial to planning a way forward, and the interest from PHAC is heartening.

2) Securing support for Antimicrobial Stewardship training module development. Our new committee had identified the development of training materials as our first priority. I just received the welcome news that our proposal, "Development of an Antimicrobial Stewardship Modular Curriculum for Infectious Diseases and Pharmacy Residents" has been supported by a grant through CCAR. There is an urgent need to develop learning materials to enrich the antimicrobial stewardship training of infectious diseases specialists in training, pharmacists and potentially other health professionals with additional antibiotic interest and expertise - including veterinarians. The project will develop a modular, case based curriculum at the learning level of Infectious Diseases and Pharmacy trainees, which can be used by multiple groups within existing training curricula or by individual learners.

Dr. Saxinger has agreed to remain on as Chair of the committee, and welcomes the continued input and expertise from AMMI Canada members.

CHEC has participated in the Canadian Nosocomial Infection Surveillance Program (CNISP), in partnership with the Public Health Agency of Canada (PHAC), formerly Health Canada, since 1995. Since our last report, there has been some progress regarding inadequate staffing with the recruitment of three senior epidemiologists and a database analyst. A manager has been appointed and Dr. Tom Wong, Director of the Community Acquired Infections Division is directly responsible for the portfolio. New Terms of Reference have been adopted as well as a Memorandum of Understanding for transfer and ownership of strains submitted for CNISP projects. CNISP surveillance endeavors are now proceeding on schedule and an initiative to implement real time web-based surveillance is proceeding with four sites participating in a pilot project this spring. The latter, if successful, should increase efficiency and timeliness of reporting. A Data Quality group has been established to address accuracy and consistency of data entry and coordination of surveillance forms.

In the meantime, and in the past year, CHEC/CNISP surveillance has been ongoing for:

- VRE
- · Clostridium difficile-associated diarrhea
- severe febrile respiratory infections
- CVC shunt and cardiac surgery
- central venous catheter-associated bloodstream infections (funded, in part, by CPSI)

It was decided to change the duration of terms for both the chairperson and the committee members to be more flexible and better allow participation of residents whose training programs are short (e.g. 2-year ID Fellowships). The revised terms allow committee members to commit for 1 year at a time, up to a maximum of 3 years. The chairperson must have served as a committee member for 1 year previously, and then may commit to terms of 1 or 2 years. Past chairs will be encouraged to remain on the committee for 1 year after their terms have ended to provide support and advice for the incoming chairperson.

In keeping with the goal of encouraging participation and involvement of associate members in AMMI Canada activities, we are looking into potential ways to include

resident members on select AMMI Canada committees. This may manifest as residents being observers who report back to the Associate Committee on other AMMI Canada activities, or they could act as a voice to give the sometimes unique perspective of those still in training. This would mirror the practice of many provincial and national medical associations, which aims to familiarize residents with the societies' structure and function. Upon completion of training, people who were already involved with an organization will be more likely to continue to contribute their time, and their familiarity with the organization (and the people) will enable them to feel more comfortable taking on greater responsibility. Additionally, having a peer report back to the associate members, explaining briefly what is going on elsewhere in the organization will help give associate members a sense of ownership and belonging, and will give the organization and its committees more visibility.

We appreciate the ongoing support of all the staff and members of AMMI Canada and we look forward to working together in the year ahead.

Credential Issues and Accreditation

Two programs were surveyed in 2008 (Université de Montréal and University of Manitoba) and both received full approval. There are currently 11 programs with full approval and one program that has provisional approval, pending the final recommendation from a mandated internal review.

The Nucleus Committee provides specific input to the Committee on Specialties (COS) regarding the accreditation of individual programs. The Nucleus Committee's discipline-specific comments and questions on the pre-survey

documentation are now provided to the program director before the visit from the Royal College survey team and the responses incorporated into the final report for the Nucleus Committee to review.

The Specialty Training Requirements in Medical Microbiology (2005), the Specific Standards of Accreditation for residency programs in Medical Microbiology (2004), and the Objectives of Training and Specialty Training Requirements in Medical Microbiology (2005) are in the process of being revised. More details need to be included to ensure the training documents "define" the discipline and adequately describe the competencies to practice as a Medical Microbiologist. The Specialty Training Requirements need to be explicit in describing the type and duration of training needed to meet the educational objectives. Updating the documents is a major undertaking, but it was one of the recommendations from the Committee on Specialties that Medical Microbiology review the Objectives of Training and ensure the distinctiveness of our specialty compared with Infectious Diseases was reflected in the documentation.

Examinations

Dr. Diane Roscoe continues in the role of Chair of the Examination Board. The examination has been moved to Ottawa, where the administrative aspects of the examination are efficiently organized by the Royal College Examination Centre, but the practical component of the examination is still held on-site at the Ottawa General because of the nature of the material examined.

The number of candidates taking the examination has been steadily increasing, with 20 candidates (14 English and 6 French) scheduled to take the exam in 2009. The Royal College examination has now replaced the separate Quebec exam from the College de Médécin du Québec, in part, accounting for the increase in numbers. The Examination Board regularly meets in November to develop questions based on a CANMEDS "blueprint" for the examination and the exam is now fully compliant with the Royal College guidelines. In an attempt to rationalize the examination process and address concerns that the examination is too long, the Examination Board has recommended that there be a combined oral examination that covers both the laboratory and clinical components of the examination, with this change becoming effective in 2010.

Report to the Committee on Specialties

When the Committee on Specialties agreed that the specialty of Medical Microbiology should continue as a primary specialty, a resolution was passed that " ... the specialty of Medical Microbiology continues its discussion with Infectious Diseases and other Laboratory Medicine disciplines to ensure the viability and relevance of the discipline to societal needs". A combined meeting of the Medical Microbiology and Infectious Diseases Specialty Committees was held in Ottawa on 1 May 2008 to examine in detail the similarities and differences between the two disciplines and provide an opportunity for the two Committees to work together to strengthen their programs. The meeting concluded with a clearer picture of the differences between the disciplines and how these differences need to be articulated in the training documents. There was a better understanding of where there might be an overlap in training while recognizing the distinctive laboratory focus of Medical Microbiology and the importance of a background in Internal Medicine/Paediatrics in Infectious Diseases. The importance of maintaining the distinctive and separate specialties of Medical Microbiology and Infectious Diseases was affirmed while retaining the flexibility to train in both.

Each committee agreed to look specifically at their objectives of training and revise them as necessary to ensure they represent the current clinical and societal expectations of their discipline. The Specialty Committees will work together to define the areas of common competence and along with the Chairs of the two examination boards, discuss whether these could be incorporated into a common evaluation process.



Royal College of Physicians and Surgeons of Canada Specialty Committee in Infectious Diseases

There have been three changes to the Nucleus Committee since last year's Annual Report. New members are Drs. Taj Jadavji (Region 1), Stephen Sanche (Region 2), and Hélène Senay (Region 4), joining Drs. Andrew Morris (Region 3) and Todd Hatchette (Region 5). Thank you to Drs. Wayne Ghesquiere, Kurt Williams, and Jane MacDonald for their contributions. Ex-officio members are Dr. Fiona Smaill (Chair, Specialty Committee in Medical Microbiology) and Dr. Nicole Le Saux, our new Chair of the Examination Board. The Specialty Committee met with the Medical Microbiology Specialty Committee on May 1, 2008 and plans to meet during the Annual Conference in Toronto in June 2009. The Nucleus Committee met by teleconference on February 12, 2009.

Credentialing Issues and Accreditation

Two programs (one each adult and paediatric) were surveyed in 2008 and received full approval. A third program (paediatric) received provisional approval with an internal review. As of March 2009 there were 17 programs with full approval (10 adult and 7 paediatric), with no inactive programs, 2 programs with provisional approval (internal review in 2 years), and 1 program with notice of intent to withdraw. Updating of our specialty specific documents (Specific Standards of Accreditation for Residency Programs,

Objectives of Training, Specialty Training Requirements, and the FITER) has been started but still not completed.

Examination Board

Drs. Christian Sinave and Nicole Le Saux continued as Chair and Vice-Chair, respectively, of the Examination Board in Infectious Diseases for 2008. Dr. Le Saux becomes Chair with the 2009 examination and Dr. Wayne Gold the Vice-Chair. Members of the Examination Board in 2008 were Drs. John Embil, Joanne Embree, Wayne Gold, Andrew Johnson, Christine Lee, Michael Libman, Tim Mailman, Caroline Quach-Thanh, Annie Ruest, Valerie Sales, Lynora Saxinger, and Satchen Takaya. The examination continues in the format of two three-hour papers of short-answer questions.

Relationship between the Infectious Diseases and Medical Microbiology Training Programs

As AMMI Canada members may recall, the Royal College Committee on Specialties (COS) has, over the last few years, focused attention on our two specialty programs and questioned whether there should be just one. The differences between our two programs are not inherently clear to them. Initially the COS questioned whether Medical Microbiology should be folded into Laboratory Medicine.

Now, the question could, as easily be, whether the only program should be a combined Infectious Diseases/ Medical Microbiology program. Dr. Smaill and I have, over the last two years, provided submissions to the COS outlining why we believe that Medical Microbiology and Infectious Diseases should remain separate training programs. Both specialty committees met on May 1, 2008 to explore similarities and differences, and discuss how we might make a more objective case to maintain our separate programs. Not surprisingly, there was little consensus on how we differ. Unfortunately, the status quo will not be tenable in the long term and both Committees are going to have to come to some agreement on where their differences lie, and incorporate these into objectives of training. At the same time we will be open to areas where efficiencies and streamlining may be possible, such as combined examination questions where training objectives overlap and joint administrative activities.

As always, I want to thank those who volunteer to serve on the Nucleus Committee and Examination Board. I am always ready to consider members who wish to volunteer to serve on either.

External Promotion

In an on-going effort to develop strategic partnerships, AMMI Canada had a booth at the ICAAC/IDSA 2008 conference. We continue to promote our relationship with associations such as the British Columbia Association of Medical Microbiologists (BCAMM), L'Association des médecins microbiologistes infectiologues du Québec (AMMIQ) and the International Society of Chemotherapy for Infection and Cancer (ISC). Both BCAMM and AMMIQ are two of several cooperating societies collaborating in the upcoming 2009 annual conference.

Through education initiatives such as the People to People Citizen Ambassador Programs we are in the first stages of organizing a delegation to travel to China in November 2009. In conjunction with our website designer we are improving our website through cost effective modifications such as adding the membership directory to the members only section.

Government Relations

In June 2008 Dr. Alicia Sarabia attended the Bill C-54 stakeholders' meeting organized by the Public Health Agency's Office of Laboratory Security. Dr. Sarabia went on to represent AMMI Canada at future meetings held by the Standing Committee on Health regarding the renamed, Bill C-11 an Act to promote safety and security with respect to human pathogens and toxins.

AMMI Canada quickly responded to the appointment of the new Minister of Health, by sending a letter of welcome to the Honourable Leona Aglukkaq, P.C., M.P.

Media

AMMI Canada has been sought by national reporters to comment on various topics and we have endeavoured to develop a quick response to interview requests. In a new initiative to identify AMMI Canada spokespersons, we plan to give national health reporters a listing of AMMI Canada members that are willing to comment on specific topics. We have also aspired to improve relations with the media through advanced preparations that will allow us to disseminate more regular press releases.

Internal

In September 2008 AMMI Canada hired a Communications Coordinator on a part-time basis. The Committee will be revising its Terms of Reference to include more AMMI Canada members and longer terms for both the past president and president-elect. It is anticipated that both will serve for two-years in order to provide more continuity for the committee. In addition, members-at-large will serve for 3 years.

The 2008 AMMI-Canada – CACMID Annual Meeting was held at the Sheraton Wall Center in Vancouver, B.C. February 27 – March 1. This combined annual meeting was the largest ever with approximately 600 registered delegates. By all accounts, this was also the most successful meeting ever. In particular, Trainees Day continues to grow and attract a large number of residents in training programs in Infectious Diseases and/or Medical Microbiology. These individuals represent the future of our combined societies and providing a successful program to this audience is vital. In response to concerns that the program has insufficient clinical content, we introduced State of the Art Clinical (START) Sessions in 2008. These are intended as focused, practical clinical

reviews of common and important topics. Three START sessions were offered and were very well received. Symposia dedicated to Tick-Borne Diseases, Tuberculosis and a selection of "What's New and Hot" topics were included in the 2008 program. Two of the plenary lectures in the Tuberculosis symposium were delivered by Videoconference link with the World Health Organization. Experts in global epidemiology and TB diagnostics delivered superb lectures by video link. This was very successful and should be considered for future meetings. The 2008 annual conference was rounded out with a variety of workshops and sessions including oral abstracts and posters, industrysponsored mini-symposia, a special lecture and the ever-popular clinical vignettes. An abundance of social activities were also part of the 2008 meeting, including a gala on Saturday evening to end the conference. The conference was shorter than previous ones. No symposium was offered Sunday morning as it was anticipated that most delegates would need to leave Vancouver before noon that day.

The 2009 annual conference is being held in conjunction with the International Congress of Chemotherapy and Infection in Toronto June 18-21. Planning for this meeting has been underway for 2 years and many challenges have been encountered. The scope of this meeting is much larger

than our usual annual conference. Some of the challenges encountered have included the global economic slowdown and H1N1 Influenza, both of which will significantly impact the attendance at this meeting. While we initially aimed at approximately 2500 delegates, we now anticipate approximately 1000. An excellent and diverse scientific program has been planned.

For 2010, we will revert to our combined AMMI Canada and CACMID annual conference. This meeting is scheduled for Edmonton, Alberta May 5-9. Dr. Kevin Forward has agreed to co-chair the Scientific Program Committee for this meeting and will then assume the position of Chair of the Program Planning Committee. Anticipated challenges include trying to ensure that momentum built in Vancouver in 2008 continues. Sponsorship is likely to be a challenge as changes continue in the pharmaceutical industry, particularly if the economy remains soft.

National Infectious Diseases Day

A 3-year plan for a National Infectious Diseases Coalition was developed in 2008 and approved by AMMI Canada, CACMID and CHICA Canada, Financial commitments were received from several industry partners.

On October 23, 2008 Canada's 2000 infectious disease experts and practitioners asked Prime Minister Stephen Harper and the Government of Canada to invest \$200 million in a National Strategy to bolster the capacity of the Canadian healthcare system to diagnose, prevent, control and treat known, new and emerging infectious diseases in hospitals.

A Battle We Can Win: Reducing Healthcare Associated Infections by 50%, our report that a Canadian National Healthcare Associated Infection Strategy will directly reduce the \$1 billion annual cost to treat 250,000 Canadians whose hospital stays are prolonged by HAIs is available at www.nidd.ca

Several other organizations, including patient advocacy groups, have expressed interest in joining NIDD. The decision by AMMI Canada and CACMID to withdraw has the potential of decreasing the influence of ID physicians but also makes for a more diverse coalition.

Bill Lowthian Golf Tournament

The personal cost of infection was demonstrated in London in June at the first Annual Golf Tournament to honour Bill Lowthian who died of CA-MRSA in 2005. His family and friends have made a positive outcome of their tragedy by organizing the tournament to fund CFID's Novel Alternatives to Antibiotics Research.


