Student e-poster presentations will take place on the AMMI Canada – CACMID Conference platform beginning on Sunday, April 25th, 2021. Presentation will be available to view on the platform until Sunday, May 30, 2021. Conference delegates will have the ability to interact with poster presenters via a chat function within the platform. You will be required to monitor the chat on your poster a minimum of once a day for the duration of the live conference by logging into the Conference Platform as a delegate. Please include an email on your poster where delegates can reach you for questions following the live days.

Student e-posters must be submitted as a single page PDF poster- no narration.
